### In Attendance:

David Mears PSLCC – Town Clerk and Amy Storey – Office Administration Assistant. There were no members of the public or press in attendance. Two members of the local Police Beat Team attended the meeting to discuss policing in Bridgwater.

The representatives from Bridgwater's Police Beat Team updated the Council on the post COVID out of court disposal programme, which helps identify prior to offence. The police are aware of the antisocial behaviour in town and the 'hot hatches' racers, there are a number of PCSOs around to monitor this. There has been a drastic change during COVID of crime rate - it has decreased. There is a new PCSO on the Wyndham Ward, to overlook the gang culture and damage being caused.
